### Dollar Bay-Tamarack City Area Schools Wellness Plan

### **Preface**

MDE states: The Michigan State Board of Education recognizes and acknowledges that "schools cannot achieve their primary mission of education if students and staff are not physically, mentally and socially healthy." The Board believes that schools should provide a campus-wide environment where students are taught healthy eating and physical activity knowledge, skills, and values. In addition, the campus-wide environment should provide ample opportunity to practice these skills on a daily basis.

A local school wellness policy is a written document that guides a local educational agency's (LEA) efforts to establish a school building environment that promotes students' health, well-being, and ability to learn. The wellness policy requirement was established by the Child Nutrition and WIC Reauthorization Act of 2004, and further strengthened by the Healthy, Hunger-Free Kids Act of 2010 (HHFKA). It is specific to LEAs (local school districts, public school academies, and intermediate school districts), as opposed to School Food Authorities, that participate in the National School Lunch Program and/or School Breakfast Program. The responsibility for developing, implementing, and evaluating a wellness policy is placed at the local level so the unique needs of each school under the LEA's jurisdiction can be addressed.

The DB-TC School Wellness Plan/Policy is modeled after the MDE Model Local School Wellness Policy:

### **Policy Documents**

### **Policy Content**

### **Nutrition** Education, Promotion, and Standards

MDE dictates: Every year, all students, PK-12, shall receive **nutrition education** that is aligned with the Michigan Health Education Grade Level Content Expectations and the Michigan Merit Curriculum Guidelines for Health Education. Nutrition education that teaches the knowledge, skills, and values needed to adopt healthy eating behaviors shall be integrated into the curriculum. Nutrition education information shall be offered throughout the school campus including, but not limited to, school dining areas and classrooms. Staff members who provide nutrition education shall have the appropriate training.

### The DB-TC Board of Education has set the following goals in an effort to enable students to educate about good health and nutrition habits:

- 1. Nutrition education shall be included in the Health curriculum so that instruction is sequential and standards-based and provides students with the knowledge, attitudes, and skills necessary to lead healthy lives.
- 2. Nutrition education standards and benchmarks shall be age-appropriate and culturally relevant.
- Nutrition education standards and benchmarks promote the benefits of a balanced diet that includes fruits, vegetables, whole grain products, and low-fat and fat-free dairy products.

### NUTRITION EDUCATION STRATEGIES AND ACTIVITIES!

- -The P.E./Health teacher will follow the Michigan Model for Health curriculum at the 9th grade level, which includes nutrition instruction.
- -The P.E. teacher will teach all K-5 P.E. classes basic nutrition instruction in an age-appropriate manner.
- -The P.E./Health teacher will instruct students on the food groups and teach about and encourage healthy eating at all levels.
- -Guest teachers will come into our classrooms to present cooking and tasting lessons to students to expose them to various foods and encourage them to cook and eat healthily.

MDE states: **Nutrition promotion** and education positively influence lifelong eating behaviors by using evidence-based techniques and nutrition messages, and by creating food environments that encourage healthy nutrition choices and participation in school meal programs. Students and staff will receive consistent nutrition messages throughout school buildings, classrooms, gymnasiums, and cafeterias. Nutrition promotion also includes marketing and advertising nutritious foods and beverages to students and is most effective when implemented consistently through a comprehensive and multi-channel approach by school building staff, teachers, parents, students, and the community. The District will promote healthy food and beverage choices for all students throughout the school campus, as well as encourage participation in school meal programs.

### The DB-TC Board of Education has set the following goals in an effort to promote good nutrition:

- Create an environment that reinforces the development of healthy eating habits, including
  offering the following healthy foods that comply with the USDA Dietary Guidelines for
  Americans and the USDA Smart Snacks in School nutrition standards:
  - -a variety of fresh produce to include those prepared without added fats, sugars, refined sugars, and sodium
  - -a variety of vegetables daily to include specific subgroups as defined by dark green, red/orange, legumes, starchy, and other.
- 2. Eliminate trans-fat from school meals.
- 3. Require students to select a fruit or vegetable as part of a complete reimbursable meal.

### **NUTRITION PROMOTION STRATEGIES AND ACTIVITIES**

-A survey will be conducted annually to determine the favorite and least foods from the breakfast and lunch program along with additional foods students would like to see added to the hot breakfast and lunch menu. This survey will be conducted to see what students currently enjoy on the menu and see what foods students would want added to the menu. The purpose of the survey is to make the menus more appealing and encourage more student participation in the breakfast and lunch programs.

- -The Cultural Studies high school class will expose students to interesting and healthy foods from other cultures.
- -Healthy options will be easily accessible for all students in the lunch line.
- -Students will be offered "seconds" of healthy fruit and vegetable choices at lunch time, as possible/available.
- -There will be no form of shaming of students who have a negative lunch balance, and these students will not be deprived of food nor will they be required to perform chores. Students' parents are contacted directly regarding lunch debt (students are notified only if contact with parents was unsuccessful, and only in private).

FUTURE GOAL: Food Service staff will integrate more cooking from scratch recipes in the menu.

With the objectives of enhancing student health and well-being, and reducing childhood obesity. the following standards and nutrition guidelines are established:

- 1. All foods offered on the school campus during the school day shall comply with the current USDA Dietary Guidelines for Americans, other than those which fall under the exemption clause (below).
- 2. The food service program will strive to be financially self-supporting; however, if it is necessary to subsidize the operation, it will not be through the sale of foods with minimal nutritional value.

### STANDARDS AND NUTRITION STRATEGIES AND ACTIVITIES:

-The school breakfast and lunch menus will be available on the school website and will encourage healthy eating in a positive manner.

Exemption Clause: As of July 2015, Michigan allows two fundraisers per week per school building that do not meet the Smart Snacks standards. A fundraiser may last up to one (1) day. These exemptions are optional and are up to the schools to track on their own. They may not be sold in the foodservice area during mealtimes.

Dollar Bay-Tamarack City Area Schools personnel are aware of this exemption.

### **Policy Content**

### **Physical Education**, Physical Activity, and Other School-Based Activities

MDE Dictates: The District shall **offer physical education** opportunities that include the components of a quality physical education program. Physical education shall equip students with the knowledge, skills, and values necessary for lifelong physical activity. Physical education instruction shall be aligned with the Michigan Physical Education Grade Level Content Expectations and the Michigan Merit Curriculum Guidelines for Physical Education.

### The DB-TC Board has set the following goals related to physical education:

- 1. A sequential, comprehensive physical education program shall be provided for students in K-12 in accordance with the standards and benchmarks established by the State.
- 2. The sequential, comprehensive physical education curriculum shall stress the importance of remaining physically active for life.
- 3. Properly certificated, highly qualified teachers shall provide all instruction in physical education.

### PHYSICAL EDUCATION STRATEGIES AND ACTIVITIES:

- -The P.E. teacher will teach physical education to all K-5 classes at least twice per week, and to high school 9th grade students, as well as 6th-12th grade students as an elective.
- -The P.E. teacher will implement a 6-week fitness challenge encouraging students to exercise, especially outdoors, five out of seven days a week, requiring parents to sign off on the activity.

MDE Dictates: Students, Pre-K-12, shall have the opportunity to participate regularly in supervised **physical activities**, either organized or unstructured, intended to maintain physical fitness and to understand the short- and long-term benefits of a physically active and healthy lifestyle.

### The DB-TC Board has set the following goals related to physical activity:

- 1. Physical activity should not be employed as a form of discipline or punishment.
- 2. All students in grades 6-12 shall have the opportunity to participate in interscholastic sports programs.

### PHYSICAL ACTIVITIES STRATEGIES AND ACTIVITIES

- -K-5 students will participate in the ACES (All Children Exercising Simultaneously) event in the spring, when offered.
- -MHSAA sports programs will be offered at the junior high and high school levels.
- -Elementary basketball sports programs will be offered.
- -A 5K Walk-Run was implemented in Fall 2018, and the district intends to further promote and encourage this, especially expanding student participation.
- -A Halloween Parade will take place in late October, involving the entire K-5 student body walking several blocks through the town.
- -FUTURE GOAL: The committee will consider implementing a Walk/Bike to School event for the coming school year.

MDE Dictates: The District will **implement other evidence-based programs across the school setting** to create environments that are conducive to healthy eating and physical activity and convey consistent health messages.

### The DB-TC Board has set the following goals related to other school-based activities to promote student wellness:

- 1. The school shall provide attractive, clean environments in which the students eat.
- 2. The school utilizes electronic identification systems (PowerSchool), therefore eliminating any stigma or identification of students eligible to receive free and/or reduced meals.

### OTHER STRATEGIES AND ACTIVITIES:

- -The district will continue to use PowerSchool, with a student ID/number system which prevents students being visibly identified as FRL.
- -A Jump Rope for Heart challenge opportunity will be included in the K-6 P.E. program.

### **Policy Content**

### **Public Updates**

DB-TC Area Schools informs the public annually about the local wellness policy, including its content, using the district weekly newsletter as the medium of communication, as well as posting on the school website. The Triennial Assessment, including progress toward meeting the goals of the policy, will also be made available to the public. The District will provide information on how the public can participate on the wellness committee and assist with the development, implementation, and periodic review and update of the wellness policy. All communication will be culturally and linguistically appropriate and will be available via the district website and/or district-wide communications (email, newsletters).

### **Triennial Assessment**

Every three years, at a minimum, the district wellness policy will be assessed by the DWC. In general, the district wellness policy will be assessed twice per year at the biennial meetings. At these meetings, the DWC will consider whether the goals are being met and activities are underway, and how to improve upon school nutrition and physical wellness programs and offerings.

Triennial assessments include a review of compliance with the wellness policy, how the wellness policy compares to model wellness policies, and progress made in attaining the goals of the wellness policy.

The most recent triennial assessment is kept on file in the district office.

### <u>WELLNESS</u>

As required by law, the Board of Education establishes the following wellness policy for the Dollar Bay-Tamarack City Area School District.

The Board recognizes that good nutrition and regular physical activity affect the health and well-being of the District's students. Furthermore, research concludes that there is a positive correlation between a student's health and well-being and his/her ability to learn. Moreover, schools can play an important role in the developmental process by which students establish their health and nutrition habits by providing nutritious meals and snacks through the schools' meal programs, by supporting the development of good eating habits, and by promoting increased physical activity both in and out of school.

The Board, however, believes this effort to support the students' development of healthy behaviors and habits with regard to eating and exercise cannot be accomplished by the schools alone. It will be necessary for not only the staff, but also parents and the public at large to be involved in a community-wide effort to promote, support, and model such healthy behaviors and habits.

The Board sets the following goals in an effort to enable students to establish good health and nutrition habits:

- A. With regard to nutrition education, the District shall:
  - 1. Nutrition education shall be included in the Health curriculum so that instruction is sequential and standards-based and provides students with the knowledge, attitudes, and skills necessary to lead healthy lives.
  - 2. Nutrition education standards and benchmarks shall be age appropriate and culturally relevant.
  - 3. Nutrition education standards and benchmarks promote the benefits of a balanced diet that includes fruits, vegetables, whole grain products, and low-fat and fat-free dairy products.

B. With regard to physical activity, the District shall:

### 1. Physical Education

- a. A sequential, comprehensive physical education program shall be provided for students in K-12 in accordance with the standards and benchmarks established by the State.
- b. The sequential, comprehensive physical education curriculum shall stress the importance of remaining physically active for life.
- c. Properly certified, highly qualified teachers shall provide all instruction in physical education.

### 2. Physical Activity

- a. Physical activity should not be employed as a form of discipline or punishment.
- b. All students in grades 7-12 shall have the opportunity to participate in interscholastic sports programs.

- C. With regard to other school-based activities the District shall:
  - 1. The school shall provide attractive, clean environments in which the students eat.
  - 2. Schools in our system utilize electronic identification and payment systems, therefore, eliminating any stigma or identification of students eligible to receive free and/or reduced meals.

D. With regard to nutrition promotion, any foods and beverages marketed or promoted to students on the school campus, during the school day, will meet or exceed the USDA Smart Snacks in School nutrition standards.

### Additionally, the District shall:

- 1. create an environment that reinforces the development of healthy eating habits, including offering the following healthy foods that comply with the USDA Dietary Guidelines for Americans and the USDA Smart Snacks in School nutrition standards:
  - a. a variety of fresh produce to include those prepared without added fats, sugars, refined sugars, and sodium
  - b. a variety of vegetables daily to include specific subgroups as defined by dark green, red/orange, legumes, and starchy
- 2. eliminate trans-fat from school meals
- 3. require students to select a fruit or vegetable as part of a complete reimbursable meal

Furthermore, with the objectives of enhancing student health and well being, and reducing childhood obesity, the following guidelines are established:

- A. In accordance with Policy 8500, entitled Food Service, the food service program shall comply with Federal and State regulations pertaining to the selection, preparation, consumption, and disposal of food and beverages, including but not limited to the USDA Dietary Guidelines for Americans and the USDA Smart Snacks in School nutrition standards, as well as to the fiscal management of the program.
- B. As set forth in Policy 8531, entitled Free and Reduced Price Meals, the guidelines for reimbursable school meals are not less restrictive than the guidelines issued by the U.S. Department of Agriculture (USDA).
- C. All food and beverages that are district provided, other than through sale, on the school campus during the school day (which may include classroom snacks, for classroom parties, and at holiday celebrations) shall comply with the current USDA Dietary Guidelines for Americans.
- D. The food service program will provide all the students affordable access to the varied and nutritious foods they need to be healthy and to learn well.

The Board designates the Superintendent as the individual(s) charged with operational responsibility for verifying that the District meets the goals established in this policy.

The Superintendent shall appoint a District wellness committee that meets at least two (2) times per year and includes parents, students, representatives of the school

food authority, educational staff (including health and physical education teachers), mental health and social services staff, school health professionals, members of the public and school administrators to oversee development, implementation, evaluation and periodic update of the wellness policy. The Wellness Committee shall be an ad hoc committee with members recruited and chosen annually.

The Wellness Committee shall be responsible for:

- A. assessment of the current school environment;
- B. review of the District's wellness policy;
- C. recommendation for the revision of the policy, as necessary.

Before the end of each school year the Wellness Committee shall recommend to the Superintendent any revisions to the policy it deems necessary and/or appropriate. In its review, the Wellness Committee shall consider evidence-based strategies in determining its recommendations.

The Superintendent shall report annually to the Board on the progress of the Wellness Committee and on its evaluation of policy implementation and areas for improvement, including status of compliance by individual schools and progress made in attaining goals of policy.

The Superintendent is also responsible for informing the public, including parents, students and community members, on the content and implementation of this policy. In order to inform the public, the Superintendent shall post the policy on the District's website.

The District shall assess the Wellness Policy at least once every three (3) years on the extent to which schools in the District are in compliance with the District policy, the extent to which the District policy compares to model wellness policies, and the progress made in attaining the goals of the District Wellness Policy. The assessment shall be made available to the public on the School District's web site.

As of July 2015, Michigan allows two fundraisers per week per school building that do not meet the Smart Snacks standards. A fundraiser may last up to one (1) day. These exemptions are optional and are up to the schools to track on their own. They may not be sold in the foodservice area during mealtimes. Dollar Bay-Tamarack City Area Schools personnel are aware of this exemption.
